(SR-131) Intersection Improvements) - Amend the project by increasing STP funding in FY 2014 for construction from \$2,600,000 total (\$2,080,000 federal and \$520,000 state) by adding \$2,400,000 for a new total of \$5,000,000 (\$4,000,000 federal and \$1,000,000 state) at the request of TDOT. Amend the total project cost from \$4,164,000 to \$7,142,700.

Attachment #2C - Amendment 2014-072 (Alcoa Sidewalk/Greenway Extension) - Amend the project by adding it to the 2014-2017 TIP.
