Attachment #2B - Amendment 2011-028 (Pistol Creek Greenway – Phase IV) - Amend the project description to read "Construction of approximately 6,200 linear feet of greenway (ten foot wide paved trail) connecting to the existing Alcoa Greenway Trail." Amend the length from 0.92 miles to 1.1 miles. Amend the termini to read "Pistol Creek Phase II Greenway at Wright Rd (North) to Clayton Greenway Trail segment near Clayton Dr (South)."

Attachment #2C - Amendment 2011-061 (Pellissippi Place Greenway – Phase I) - Amend the project description to read "The construction of approximately 4,200 linear feet of sidewalk within Pellissippi Place and approximately 650 linear feet of greenway, plus amenities such as trash receptacle and benches. The greenway trail will connect an existing sidewalk along Clayton Rd to the existing City of Alcoa greenway trail that runs along Pistol Creek." Amend the length from 1.1 miles to 0.92 miles. Amend the termini to read "Connecting Alcoa Greenway Trail Clayton segment near McNutt Ave and terminating at Pellissippi Research Center."

Attachment #2D - Amendment 2011-070 (Lenoir City CBD Pedestrian Improvements) – Amend the project by adding it to the 2014-2017 TIP. Add Transportation Alternatives Program (TAP) funds for construction in the amount of \$200,000 total (\$160,000 federal and \$40,000 local) to FY 2014 for streetscape improvements along Hwy. 11/S.R. 2 (Broadway) between Grand Street and Hill Street and between B Street and C Street.

### 3. Knox County School Sidewalk Study

# Presenter: Cindy Pionke, Knox County Engineering & Public Works

**Item Summary:** The Walk-to-School Prioritization Analysis was conducted by RPM Transportation Consultants, LLC for Knox County's Department of Engineering and Public Works. GIS-based trip modeling procedures developed by the consultant along with KGIS data were used to develop walk trip estimates of the number and most likely locations of walk to school trips for each school in Knox County. These estimates will be used to aid in the determination of sidewalk construction priorities.
