# 2. PUBLIC HEARING on the Federal Transit Administration Program of Projects Presenter: Jeff Welch, TPO Staff

Item Summary: As a requirement of the Federal Transit Administration (FTA) a Public Hearing will be held during the Executive Board meeting to allow for public input regarding the proposed transit Program of Projects (POP). The POP is a specific list of projects to be funded by each agency. After all comments have been received, the Public Hearing will be officially closed. Each fiscal year the urban area receives from the FTA an allocation of Section 5307 – Urban Area and Section 5339 Bus and Bus Facilities Grant funds. The City of Knoxville is the Designated Recipient of these funds. The Executive Board at its April 26, 2017 meeting approved a distribution formula based on percentages for how the FTA funds would be distributed to KAT, Knox CAC Transit, and ETHRA. At the April Board meeting, Congress had not passed the complete FY 2017 federal transportation budget. Therefore, the final dollar amounts allocated to each agency was unknown. On May 5, 2017 the President signed an omnibus spending package that completed the appropriations process for FY 2017. The TPO then had to wait for the FTA to publish Knoxville appropriation in the Federal Register.

Attachment #4A - Amendment 17-2017-032 (Duck Pond Walking and Bike Path Phase 2) — Amend the project by adding it to the TIP. This project has \$692,975 (\$554,380 federal/\$138,595 local) in HPP funds in FY 2017 for construction. This project will involve construction and renovation of multi-use path in conjunction with other phases of the project.

Attachment #4B - Amendment 17-2014-033 (Chapman Hwy. (SR-71) Improvements) – Amend project to add \$6,100,000 (\$4,880,000 federal/\$1,220,000 state) of NHPP to FY2017 for construction. The construction cost has been increased as per the detailed estimate that was recently received. The original total project cost was incorrect on the TIP page. Therefore, the amended total project cost reflects the error correction and additional funds.
