1. Motion to Approve June 13, 2017 TPO Technical Committee Minutes

Item Summary: Approval of the June 13, 2017 TPO Technical Committee Minutes.

A Motion was made by Cindy Pionke and seconded by Gerald Green to approve the June 13, 2017 TPO Technical Committee Minutes. The Motion carried unanimously.

2. Motion to Recommend Approval of a Resolution to Amend the FY 2017-2020

 $Transportation\ Improvement\ Program\ (TIP)$

Item Summary: Staff recommends approval.

Discussion: Elizabeth Watkins reviewed the proposed amendments, one adding the Duck Pond Walking and Bike Path Phase 2 project for construction and renovation of a multiuse path in conjunction with other phases of the project in the City of Alcoa, and although it is going before the IAC staff believe the project to be exempt from air quality conformity. A second project is adding additional funds to an existing TDOT project involving improvements to Chapman Highway (SR-71) in Sevier County, primarily reflective of higher than anticipated estimates.

A Motion was made by Jeff Ownby and seconded by Jack Qualls to recommend approval of a Resolution to amend the FY 2017-2020 Transportation Improvement Program (TIP). The Motion carried with Gerald Green voicing opposition to recommending approval of an Amendment to TIP for project 17-2014-033.

3. Motion to Recommend Approval of a Resolution to Adopt the Draft FY 2018-2019 Transportation Planning Work Program (TPWP)

Item Summary: TDOT, FHWA and FTA have approved the Work Program for consistencies with state and federal regulations. Staff recommends approval. Discussion: Jeff Welch noted the program outlines the proposed activities for the TPO and our local, state and federal planning partners for the next 2 years, beginning October 1, 2017 and going through to September 30, 2019. This 2-year Program is updated annually. There was no discussion.

A Motion was made by Blake Sartin and seconded by Gerald Green to recommend approval of a Resolution to adopt the Draft FY 2018-2019 Transportation Planning Work Program (TPWP). The Motion carried unanimously.

4. Presentation on L-STBG Obligations and FY2017-2020 Transportation Improvement Program Status Update

Item Summary: Staff will report on FY2017Q3 Local-Surface Transportation Block Grant obligations and general status update of projects in the FY2017-2020 TIP.

Discussion: Elizabeth Watkins reviewed the report noting their purpose is to share obligations progress on our regional projects with members of the Technical Committee and Executive Board as well as to measure efficacy of programming policies. She touched on the FY 2017 L-STBG forecast also reviewing multiple reasons timely obligation of federal funds benefits our region. She then touched on the progress of obligating FY 2017 TAP funds and closed with a brief review of FY2017Q3 adjustments. 5. Presentation on 2016 Travel Time Reliability Report

Item Summary: This presentation will provide an overview of various travel time and congestion-related statistics for the year 2016 on the National Highway System roadways within the Knoxville Region. This information will help prepare the TPO to respond to new performance management requirements under the FAST Act for congestion reduction and system reliability. The research for this report was conducted under a grant from FHWA as part of the 2nd Strategic Highway Research Program (SHRP2) in conjunction with TDOT.

Discussion: Mike Conger introduced Richard Margiotta with Cambridge Systematics, Inc. Mr. Margiotta began with a brief overview of the project and the history of measuring congestion, noting the main purpose of these grants is to implement the research products from SHRP2.

He then explained travel time reliability and the measure of congestion in general, detailing data collected for the Knoxville region over 3 years, 2014-2016.
